June 16, 2014 Meeting

The June 16, 2014 meeting of the Parkwood Garden Club (PGC) Board of Directors was held at 220 Upland Rd., Decatur, GA. The meeting was called to order at 7:21 pm. The following officers and committee chairs attended: Steve Elmore, Sean Pruett, Becky Vocaire, Tom Bell, Karna Candler, Sheri Kennedy, Katy Mallory, Christina Carter

Overview of Robert's Rules, Review Board Member's Roles, Communication – Karna Candler

- A. The Board read through Robert's Rules Script to familiarize new members with procedure
- B. Board members to give secretary any reports prior to scheduled meetings
- C. Minutes will be posted to the PGC website, once approved, with the committee reports. PPC and the Historic Committee shall submit reports to Webmaster (Bryan Bell) if they need to be posted more frequently.
- D. Email Marketing Tool:
  - a. If a committee has an email to get out to the neighborhood, copy Katy Mallory, Sean Pruett, and Becky Vocaire. Katy Mallory suggests using MailChimp to organize correspondence. PGC members can elect what information they wish to receive from the PGC. We can customize a template, calendar, archive, etc. It was stated that members should be able to opt out of emails, as opposed to opting in.
  - b. MailChimp is a service not an outside party so this would not infringe on the board's decision last year that PGC members' email addresses are not to be distributed outside of the board.
  - c. The board should make an effort to consolidate emails. Check with other board members to make sure no one else has anything else to add before hitting send.
  - d. Mondays and Fridays should be avoided for sending announcements to increase the likelihood of the emails being read. The announcements will dictate the regularity of the schedule.
- E. Nation of Neighbors City of Decatur should be selected in the user's profile. Communication should be sent to neighborhood in order to have more people sign up. Karna shall talk to Bryan about some of the crime/safety aspects that should be sent to the whole neighborhood. Only about 50% of the neighborhood is signed up for Nation of Neighbors.

Tom Bell moves we remove the password protection on the PGC website. Sheri Kennedy seconds. There is a discussion about what the cons may be of removing the password. It was stated that the members have a right to know what happens in the meetings. Vote on removing the password on the meeting minutes: 7 aye, 1 nay. The motion is adopted.

### Update on Historic District Project – Tom Bell

- 3. Parkwood Ordinance Final Draft This will go into the city code chapter 58-12 in effect as of July 7th
- 4. Parkwood Designation Report
- B. The board needs to get involved after July 7<sup>th</sup> to promote involvement in the neighborhood for a discussion on the HPC. The entire neighborhood should be present at City Hall on Aug 5<sup>th</sup> at 7p. Regina will host a walk through of the neighborhood on Aug 9<sup>th</sup>
- C. Tom will be the point of contact to establish Parkwoods Local Historic Committee (PLHC).
- D. There should be discussion on whether we want to go after a National Register nomination. A benefit of this is that homeowners can receive grants on remodeling. It is expensive to be part of the Nation Register, however, there are grants up to 60% and COD could possibly cover 50% of the Parkwoods' 40% portion.
- E. Repairs for sidewalks/streets need to be sent to the city manager in a letter. To get a sidewalk fixed, use the CRM system on the Decatur website. Sheri and Tom will survey

"The bylaws update is not on the agenda for June's DHCA meeting. The DHCA Board is waiting on the official annexation date of July 1<sup>st</sup> and the approval of the interim historic district (July 7<sup>th</sup>) before proposing the changes to the bylaws. Once the historic district is approved on July 7<sup>th</sup>, the DHCA Board will discuss the language changes for border descriptions at the July meeting. If the Board approves the recommendation, it will have to be voted on at the DHCA Annual Meeting in Jan/Feb 2015. All changes to the bylaws have to be voted on at the Annual Meeting."
